- Personal arrangements/deviations from the printed music were not clearly marked on the judges' score(s).
- Same selection as one presented by another participant/group from the same school in same category/grade.
- Solo or Duet was not performed within the one (1) and eight (8) minute time limit.
- Small Group, Duet, or Solo performance was directed.
- Dancing, moving feet out of place, moving lower body, or inappropriate upper bodily movement was used.
- Accompaniment (if used) was not acoustic (exception: Inspirational Vocal Solo)
- Vocal lyrics were not memorized - sheet music used.
- In Inspirational Vocal Solo, participant did not use a music track.
- In Inspirational Vocal Solo, the performer was not present at the time of the performance. (exception: Inspirational Vocal Solo)
